The minutes of the Supervisors of the Checklist for the Town of Londonderry

Chairperson Kristin Grages called the meeting to order at 6:00pm. Present were Supervisors Kristin Grages and Maureen Hardy. Absent was Barbara MacDonald.

The Supervisors reviewed and entered new voters, reviewed and amended existing voters for name, address and party changes, and, where available, reviewed evidence from the SVRS database, the NH Department of Vital Records, the NH Department of Corrections, and formal notice from other States to remove voters. The full count and names are included below as attached. The Supervisors printed out a list of removed voters to be used to organize the physical voter files. All voter records removed from the active files will be retained for seven years.

The Supervisors prepared for the upcoming Town and School Deliberative Sessions.

The Supervisors will meet next February 28 from 10-11am at the Town Clerk's Office.

Kristin Grages motioned to approve November 5, 2025 Minutes. Maureen Hardy seconded. All voted in favor.

Kristin Grages motioned to approve the addition or amendment of 56 voters. Maureen Hardy seconded. All voted in favor.

Kristin Grages motioned to approve the removal of 111 voters due to death, 30-day notice, registering outside of Londonderry or voter ineligibility. Maureen Hardy seconded. All voted in favor.

Kristin Grages motioned to adjourn at 7:30 pm. Maureen Hardy seconded. All voted in favor.
