5. COMMITTEE BUSINESS

A) Bond Authorizing and Issuance Process:

Peter Curro called into the meeting and discussed the bond schedule. P. Curro will add the lease for the SAU building to the bond/lease schedule. Sixty percent approval is required for a bond to pass. At authorization, it does not affect the tax rate. Once the bond is sold, then it gets factored into the budget. A bond authorization can remain for any period of time, until it is rescinded or sold. P. Curro also mentioned that if we do decide to move forward with the elementary school projects, they should be done together. In terms of priorities for the capital projects, P. Curro believes the first priority should be the first phase of the Moose Hill project, then the high school, and then elementary schools.

B) Leadership Londonderry:

The committee members reviewed the Leadership Londonderry schedule and confirmed that S. Breault and R. Dunn will attend the Leadership Londonderry session on November 17, 2022 and speak to the class about budget committee.

C) Review Capital Improvement Program (CIP) projects:

The committee members reviewed the list of CIP projects. S. Breault provided an outline of what was discussed during the CIP meeting on 07/25/2022. He mentioned that during the meeting they also discussed some possible changes to the CIP scoring forms and including the School Board in the scoring process. During the CIP scoring process, there was a focus on Moose Hill and the high school to highlight the areas that need the most attention. The plywood flooring in the high school is of particular concern, since the high school footprint cannot be expended any larger. As for Moose Hill, it is undersized and they would need to almost double the size if the building to accommodate full-day kindergarten.
