REMOTE MEETING

Per Emergency Order #12 Pursuant to Executive Order 2020-04, during the current declared State of Emergency, the Governor has waived the requirement in RSA 91-A:2, III (b) that a quorum of a body be physically present as it relates to public meetings. Under the same directive, the Governor has also waived the requirement in RSA 91-A:2, III(c) that each part of a meeting of a public body be audible or otherwise discernable to the public "at the location specified in the meeting notice as the location of the meeting." These two requirements are waived so long as the public body:

1. Provides public access to the meeting by telephone, with additional access possibilities by video or other electronic means;
2. Provides public notice of the necessary information for accessing the meeting;
3. Provides a mechanism for the public to alert the public body during the meeting if there are problems with the access; and
4. Adjourns the meeting if the public is unable to access the meeting.

In accordance with this directive, the Londonderry Conservation Commission will conduct its meeting as follows:

1. The public shall have access to participate in the meeting by telephone. To join via telephone, the public may call 1-312-626-6799 and when prompted, enter the Event ID (816 8966 1653) and then the password (089932). 2. This notice serves as the public notice of the necessary information for accessing the meeting.
3. You may also provide public testimony via e-mail, please e-mail your testimony to akizak@londonderry.org by June 9, 2020 no later than 5:00 p.m. Your testimony will be read into the public record at the meeting.
4. The Commission encourages that any documentation that you wish for the Commission to consider be submitted by June 9, 2020 no later than 5:00 p.m. to allow distribution to the Commission at the virtual meeting. 5. If you attempt to call in to the meeting to provide public testimony and are unable to access the meeting, please notify Planning Staff during the meeting by calling 603-247-7301 or sending an email to cmailloux@londonderry.org.
6. If during the meeting there are problems with access, Planning Staff will alert the public and the Chair of Conservation Commission; and
7. If at any time the public is unable to access the meeting, the meeting will be adjourned and continued to a date certain.
