REMOTE MEETING

Per Emergency Order #12 Pursuant to Executive Order 2020-04, during the current declared State of Emergency, the Governor has waived the requirement in RSA 91-A:2, III (b) that a quorum of a body be physically present as it relates to public meetings. Under the same directive, the Governor has also waived the requirement in RSA 91-A:2, III(c) that each part of a meeting of a public body be audible or otherwise discernable to the public "at the location specified in the meeting notice as the location of the meeting." These two requirements are waived so long as the public body:

1. Provides public access to the meeting by telephone, with additional access possibilities by video or other electronic means;
2. Provides public notice of the necessary information for accessing the meeting;
3. Provides a mechanism for the public to alert the public body during the meeting if there are problems with the access; and
4. Adjourns the meeting if the public is unable to access the meeting.

In accordance with this directive, the Solid Waste Environmental Committee (SWEC) will conduct its meeting as follows:

1. The public shall have access to participate in the meeting by telephone. To join via telephone, the public may call 1-(224) 501-3412 and when prompted, enter the Access Code: (153-425-421).
2. This notice serves as the public notice of the necessary information for accessing the meeting.
3. You may also provide public testimony via e-mail. Please e-mail your testimony to rkerry@londonderrynh.org by May 10, 2021 no later than 12:00 PM. Your testimony will be read into the public record at the meeting.
4. The SWEC encourages that any documentation that you wish for the SWEC to consider be submitted electronically by May 10, 2021 no later than 12:00 PM to allow electronic distribution to the Board prior to the virtual meeting. You can submit documentation via email to rkerry@londonderrynh.org
5. If you attempt to call in to the meeting to provide public testimony and are unable to access the meeting, please notify Lynn Wiles during the meeting by calling 603-560-5595 or sending an email to lynnbwiles@gmail.com.
6. If during the meeting there are problems with access, Lynn Wiles will alert the public and the SWEC members; and
7. If at any time the public is unable to access the meeting, the meeting will be adjourned and continued to a date certain.
