

## Londonderry Budget Committee Meeting Notice

**REMOTE MEETING**

Per Emergency Order #12 Pursuant to Executive Order 2020-04, during the current declared State of Emergency, the Governor has waived the requirement in RSA 91-A:2, III (b) that a quorum of a body be physically present as it relates to public meetings. Under the same directive, the Governor has also waived the requirement in RSA 91-A:2, III(c) that each part of a meeting of a public body be audible or otherwise discernable to the public "at the location specified in the meeting notice as the location of the meeting." These two requirements are waived so long as the public body:

1. Provides public access to the meeting by telephone, with additional access possibilities by video or other electronic means;
2. Provides public notice of the necessary information for accessing the meeting;
3. Provides a mechanism for the public to alert the public body during the meeting if there are problems with the access; and
4. Adjourns the meeting if the public is unable to access the meeting.

In accordance with this directive, the Londonderry Budget Committee will conduct its meeting as follows:

1. The public shall have access to participate in the meeting by telephone. To join via telephone, the public may call (929) 205- 6099 and when prompted, enter the Event ID (965 2047 6621), and there is no passcode. Or utilize the following link: <https://zoom.us/j/96520476621>
2. This notice serves as the public notice of the necessary information for accessing the meeting.
3. You may also provide public testimony via e-mail. Please e-mail your testimony to [budgetcommittee@londonderrynh.org](mailto:budgetcommittee@londonderrynh.org) by April 23, 2020 no later than 12:00 PM. Your testimony will be read into the public record at the meeting.
4. The Budget Committee encourages that any documentation that you wish for the Budget Committee to consider be submitted electronically by April 23, 2020 no later than 12:00 PM to allow electronic distribution to the Board prior to the virtual meeting.
