

ORDINANCE #2003-01

An Ordinance Relative to the
***Amend Municipal Code - Title II- Traffic Safety Code,
Chapter II - Traffic Safety Committee, Section I -Membership***

WHEREAS The 1992 Town Meeting voted unanimously, under Article No. 23, to adopt the provisions presented to amend the Municipal Code, Chapter VII, Traffic Ordinance, adding Section 7-1 to create a Traffic Study Committee; and,

WHEREAS The 1995 Town Meeting voted unanimously, under Article No. 27, to revise the Traffic Ordinance, Amending Section 7-11a, to revise the name of the Committee from "Traffic Study Committee" to "Traffic Safety Committee"; and,

WHEREAS The Londonderry Town Council, at its meeting of April 4, 2002, voted unanimously to adopt Ordinance 2002-05, which revised certain sections of the Municipal Code, and revising the code from Section 7 to Title II - Traffic Code; and,

WHEREAS The Town Council may, pursuant to the provisions of RSA 72:39-b consider and act upon the question in accordance with its normal procedures for passage of resolutions, ordinances and other legislation;

NOW THEREFORE BE IT RESOLVED by the Londonderry Town Council that the Municipal Code, Title II - Traffic Safety Code, Chapter II - Traffic Safety Committee, Section I - Membership, is hereby amended as attached.

CHAPTER II - TRAFFIC SAFETY COMMITTEE

SECTION I MEMBERSHIP

- A. There shall be a Traffic Safety Committee consisting of the following) members:**
- 1. Chief of Police, *or designee***
 - 2. Town Manager**
 - 3. Public Works Director**
 - 4. Superintendent of Schools (or designee)**
 - 5. Member of the Town Council**
 - 6. *Two Members of the Public - One from business community, and one member at large***
 - 7. *Fire Chief, or designee***

SECTION II PURPOSE

- A. The Traffic Safety Committee shall study, plan and issue an annual report to the Town Council.**

SECTION III RULES AND REGULATIONS

- A. The Traffic Safety Committee shall adopt such rules and regulations for the exercise of their functions granted herein and shall submit these rules and regulations to the Town Council for approval prior to adoption.**
- B. The Traffic Safety Committee shall adhere to the U.S. Department of Transportation Federal Highway Administration Manual on Uniform Traffic Control Devices (MUTCD) and the New Hampshire Department of Transportation publication "*Traffic Control Standards, Statutes, & Policies*" as amended from time to time and as adopted by Town Meeting, 1994.**
- C. Requests and Notifications**
- 1. Members of the Committee may bring any issues of safety that they may deem necessary by requesting that the Chairman place the item on the agenda of any Traffic Safety Committee meeting.**
