UNFINISHED BUSINESS

Rt 128 @ 28 – Smith Lane intersection – Public Works Director Czyzowski advised the committee this intersection is all set.

High Range Road – Homeowner is moving her mailbox to the other side of road.

Fairway – Public Works Director Czyzowski advised the committee this issue is all set.

Shady Lane – Captain Bernard advised the committee that a directed patrols and radar units were placed in this location, saw no significant issues, average speed was 36 mph.

Harvey Road – Homeowner advising of the parking on Harvey Road and emergency vehicles unable to get through. Chairman Ramsay to call Homeowner and invite to next meeting on April 6, 2020.

Parmenter Road – Homeowner advising of speeding on the road and being used as a cut through. Captain Bernard advised the department will do directed patrols and radar to the area.

Warning signs could be posted indicating an intersection ahead and the “suggested speed” of 25 mph.
